## AFFIDAVIT

I, Thakur Dharmendra Prasad Singh, S/O- Laxman Prasad Singh, aged about 55 years resident at Najirpur, Sheikhpur, Muzaffarpur, Bihar, Secretary of the Society "Satya Manav Uthhan Sansthan", running the school S. L. Mary International School at Bangra Hardas, Kudhani, Muzaffapur, Bihar do hereby solemnly affirm and declare that-

1. That "Satya Manav Uthhan Sansthan" is a registered society under the act of 21, 1860.
2. That the Satya Manav Utthan Sansthan is a Non-proprietary Character.
3. That no member of SMC and Society are related to each other.
4. That the school is being run as community service and not as business and that commercialization does not take place in the school in any shape whatsoever.
5. That no part of income from the institution shall be diverted to any individual in the Society registered under section 25 of the companies act, 1956. School Management Committee or to any person. The savings, if any after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds may be further utilized for promoting the school.
6. That the school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.
7. That the school will not open classes under CBSE pattern particularly class IX/X and will not use CBSE name in any manner without obtaining affiliation.
8. That the Principal and Correspondent/Manger of the School have individually gone through the provisions contained in the affiliation and examination bye-laws and circulars issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation and examination bye-laws, directions issued by the board from time to time and law of the land.
9. The school will ensure compliance of all statutory requirements like E.P.F, E.S.I and labour Laws etc. with respect to the school and staff of the school.
10. That the school will ensure that the Building safety, Fire safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.



11. That the school will ensure that all required infrastructure is available with the school before starting classes.
12. That the school ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
13. That the school will follow the provisions related to fee contained in affiliation bye-laws and will disclose the details of the fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
14. That the school will not coerce any student/parent to buy books/stationery/uniform from any particular shop.
15. That the school shall strive to make efforts for conservation of environment.
16. That the school will ensure that the school fulfills all essential requirement before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation bye-laws or notified time to time.
17. That the school will not start CBSE pattern classes without submitting a commencement certificate to the effect that the school has complied with all the conditions imposed by CBSE and the post affiliation conditions contained in affiliation bye-laws along with general rules.
